Motion Carried.

The DPW Committee has been in discussion with the Parks Committee and is asking the council to purchase a storage container that the park committee could use during their park renovations and thereafter can be utilized by the DPW Committee. Holmes motioned to spend up to \$3,600.00 on a container, 2nd by Wellman. Roll Call Vote-Yes-Holmes, Bacon, Voyles, Wellman, Wert, Mongar, Treiber. -No-None. All in Favor. Motion Carried.

Dennis Karczynski is still working diligently on the Garbage proposal.

The Village sent out new animal Permit applications to all previous permit holders we received two back, one from Donnie Holmes for chickens and ducks and one Tim and Judy Baker for chickens. Mongar motioned to accept both permits 2nd by Bacon.

The park committee is having a meeting Tuesday February 21 at 3:00pm.

The Village Properties need to be looked over by a lawyer, we are looking for a less expensive lawyer for this.
