Ordinance No. 1. The Village of Luther ordains:

Sec. 1. No person or persons shall remove or cause to be removed <sup>12<sup>th</sup></sup> ~~SEP~~ 1980 or aid or assist in moving any building or other heavy or bulky article into, along or across any street, lane or alley without *Shirley K. Rogers* first obtaining permission from the Village Council which, if obtained, may contain such restrictions as the council may deem proper.

Sec. 2. No person shall have any bicycle, sled, snowmobile, motorcycle, motor bike or other vehicle on any lane, alley or sidewalk at any time causing obstruction of traffic or pedestrians, with the exception that snowmobiles will not be allowed as North and South traffic between Maple and Birch Streets on State Street.

Sec. 3. No person, in building, tearing down or repairing any building, shall permit any lumber, brick or other material to remain on any street, lane, alley or sidewalk without the permission of the Council.

Sec. 4. No person shall obstruct or encumber any public street, lane or alley with any article or thing whatever, or encroach upon or permit to remain in any such street, alley or lane any obstruction or encumbrance of whatever nature except the temporary obstruction and encumbrance of sidewalk for the purpose of receiving and discharging goods and merchandise.

Sec. 5. It shall not be lawful for persons to assemble or congregate in the streets or on the sidewalks so as to impede or obstruct the travel therein or thereon.

Sec. 6. No person shall suspend or place from or in front of any house, shop, store, wall, or fence on State Street any lamp sign, goods, wares, substances, or things, except awnings, so the same shall extend or project therefrom more than three feet.

Sec. 7. It shall not be lawful for any person or persons to place or cause to be placed any inflammable or combustible matter or material

Sec. 8. No person or persons shall place, deposit, or throw or cause it to be done any refuse, debris, or garbage of any kind or nature in or on any public street, lane or alley of the Village.

Sec. 9. No person or persons shall leave any car, motorcycle, snowmobile, truck, tractor, trailer, or any other vehicle on any street in the Village from November first to April first, after the hour of 2 a.m. and before 7 a.m. If a vehicle is obstructing the plowing of snow of any of the streets, the vehicle will be removed at owners expense.

Sec. 10. Any violation of the provisions of this ordinance shall be punished by a fine not to exceed one hundred (\$100.00) dollars and cost of prosecution or ninety days in the County jail.

Ordinance No. 2. The Village of Luther ordains:

Sec. 1. It shall be unlawful for any person to permit any dogs, horses, mules, cattle, sheep, goats, or swine to go run or be at large within the limits of the Village of Luther at any time.

Sec. 2. No person shall keep cattle, goats, kids, hogs, sheep, horses, and other livestock, including poultry, unless they shall have first obtained a permit.

Sec. 3. All animals designated in Sec. 2 hereof presently within the Village limits shall not be deemed in violation of this ordinance after the date of August 10, 1971. The owner of an animal deemed in violation of this ordinance shall forthwith register and apply for a permit from the Village Clerk. The permit to keep said animal, if issued, shall expire 12 months from the date issued. The fee for the permit shall be five (\$5.00) dollars. Any permit granted hereunder shall be subject to revocation or suspension by the Village Council when an objectional condition exists and is not removed within five days after receipt from the Village Clerk of a notice to remove the objectionable condition.

Sec. 4. (Every person convicted of a violation of any provision of this ordinance...

act of violation, and every day upon which such violation shall occur, shall constitute a separate offense. In addition to the penalty applicable to a violation of this ordinance, any person keeping an animal designated in Sec. 1 shall be guilty of maintaining a nuisance per se and, upon application by the Village to any Court of competent jurisdiction, the maintenance of such nuisance may be restrained and enjoined.

Ordinance No. 3. The Village of Luther ordains:

Sec. 1. It shall be unlawful for the owners, occupants, or leasee of any lands within the corporate limits of the Village of Luther to permit or allow any thistle, dock, milk-weed, red root, or any noxious weeds to grow and go to seed upon any land owned, occupied, or leased by them or in any street, lane, or alley adjacent thereto.

Sect. 2. It shall be the duty of every owner, occupant, or leasee of any land within the corporate limits of the Village of Luther to cut down and destroy all thistle, dock, milk-weed, red root, and all noxious weeds found growing upon any lands owned, occupied, or leased by them and in any street, lane, or alley adjacent thereto.

Sect. 3. It shall be the duty of the Street Committee to visit from time to time all parts of the Village and see that the foregoing provisions of this ordinance is being complied with; and in case any owner, occupant, or leasee shall neglect to cut down and destroy any thistle, dock, milk-weed, red root, or any noxious weeds found growing upon their premises or upon the street, lane, or alley adjacent thereto, 15 days thereafter when notified so to do by the Street Committee it shall there be the duty of said Street Committee upon approval of the Village Council to enter upon any premises or in any street, lane, or alley where any afore-mentioned weeds are growing and to cut down and destroy the same and to make report thereof to the Village Council at the next regular meeting together with his charge

or the owner of such lot or premises, if the same are not occupied, shall clear all ice and snow from the sidewalks adjoining such lot or premises within the time herein required. When any snow or ice shall cease to fall during the daylight hours, such snow or ice shall be cleared from the sidewalks within twelve (12) hours after such cessation. When a fall of snow or ice shall have ceased during the nighttime, it shall be cleared from the sidewalks by 6:00 P.M. of the day following.

Sect. 5. The charges and expenses of notifying and expenses of cutting down and destroying and said weeds incurred by the Village Council shall become a proper charge against the lands where said labor was performed and shall be assessed and collected against said lands in the manner prescribed for the collection of special assessments in other cases.

Ordinance No. 4. The Village of Luther ordains:

Sec. 1. No person shall make or assist in making any noise, disturbance, or improper diversion or engage in any rout, riot, or improper or disorderly conduct by which the peace and good order of the Village shall be disturbed.

Sec. 2. No person shall use any profane, obscene, or violent language or conduct themselves in any unseemly manner on any public street, lane, alley, or in any house, building, store, or place in the Village kept for the purpose of public business.

Sec. 3. No person shall ignite or discharge any fire or cannon crackers, torpedo, pistol, sky rocket, Roman candle, or any other explosive or combustible matter or build, kindle, light, or ignite any combustible matter, for the purpose of making a bon-fire upon any street, lane, or alley within the corporate limits of the Village in the nighttime except on legal holidays and days appointed by the President of the United States, the Governor of this State, or by the Village Council as a holiday.

one hundred (\$100.00) dollars and cost of prosecution or, in default of the payment of said fine and cost, to be and remain imprisoned in the County Jail until said fine and cost are paid provided that said imprisonment shall not exceed ninety days.

Ordinance No. 5. The Village of Luther ordains:

Sec. 1. It shall be unlawful for any person to be drunk and/or disorderly in any store, church, or building used for the purpose of public business or on any street, lane, or alley within the corporate limits of this Village.

Sec. 2. Any person violating the provisions of this ordinance shall, upon conviction thereof, be liable to a fine not exceeding one hundred (\$100.00) dollars and costs of prosecution or, in default of the payment of said fine, to be and remain imprisoned in the County Jail not exceeding ninety days.

Ordinance No. 6. The Village of Luther ordains:

Sec. 1. It shall be unlawful for any person to discharge any firearms within the limits of the Village.

Sec. 2. It shall be unlawful for any person to exhibit or display any firearms or other dangerous weapons in any street or public place within the corporate limits of said Village to the annoyance or terror of any person or persons.

Sec. 3. Any person violating any of the provisions of this ordinance shall, on conviction thereof, be punished by a fine not to exceed one hundred (\$100.00) dollars or, in default thereof, by imprisonment in the County Jail not to exceed ninety days.

Ordinance No. 7. The Village of Luther ordains:

Sec. 1. No person or persons whose profession or circumstances takes them from door-to-door selling, soliciting, taking surveys

Sec. 2. No person or persons may bring in or cause to be brought in any circus, carnival, menagerie, or other outdoor entertainment without first obtaining a permit with whatever restrictions the Council deems proper.

Sec. 3. No person or persons holding a permit from the Council shall use that permit for any other purpose other than that for which it was obtained and any permit used otherwise, or if obtained through false pretenses or by misrepresentation shall thereby be revoked and invalidated.

Sec. 4. Any violation of or failure to comply with the provisions of this ordinance shall be punished by a fine not to exceed one hundred (\$100.00) dollars and costs or, in default thereof, by imprisonment in the County Jail not to exceed ninety days.

Ordinance No. 8. The Village of Luther ordains:

Sec. 1. It shall be unlawful for any person to nail, tack, or fasten any sign, notice, or advertisement upon any building, structure, tree, or pole within the Village without first obtaining permission of the owner thereof.

Sec. 2. Any person violating the provisions of this ordinance shall, upon conviction of said offense in any court of competent jurisdiction, be punished by a fine not exceeding one hundred (\$100.00) dollars or ninety days or such fine and imprisonment in the discretion of the court.

Ordinance No. 9. The Village of Luther ordains:

Sec. 1. It shall be unlawful for any child under the age of Eighteen years to loiter or congregate on the streets, alleys, or public places of the Village after 10:00 o'clock p.m. unless accompanied by parents, or legal guardian. Violators will be prosecuted according to the laws of the State of Michigan.
