Grant updates: We have received \$3,500 from LCCF for an air pak. And \$5,000 from GLPFand both air paks have been ordered. A new quote was obtained for the air paks. We will be heading around Dec 15^{th} if we received the DNR grant for an air pak as well.

Firehouse subs grant was submitted on 10/12 for the stryker lucas.

We received \$30k from the Mi Fire Equipment grant from the Townships and Village. We have until 12/31 to submit proof of payment. The quote totals \$54k. Danielle will keep looking for grants for this as well. A new quote obtained for \$30,600 for 18 portable radio obtained to complete the grant for \$30,000 by December 31st.

Danielle provided a copy of the revised Rental Agreement making an amendment that the department can accept or reject any rental request.
